### GARAGE SALE PERMIT

#### **PROCEDURE:**

- 1) Complete the attached Garage Sale Permit form with all required information:
  - a. You may hold a garage sale for two consecutive days on the weekend from 9:00am until 6:00pm and only two garage sales are permitted per year.
  - b. You must know the exact date(s) you plan on holding your garage sale prior to submitting your Garage Sale Permit form to the Clerk's Office.
  - c. You may want to include a rain date on the form.
- 2) Bring the completed Garage Sale Permit form to the Clerk's Office on the 2<sup>nd</sup> floor of the Borough Hall at 214 Ridge Road.
- 3) When paying the **\$6.00 fee** by cash, you must bring exact change. Checks and money orders are also accepted and payable to the 'Borough of North Arlington'.
- 4) To ensure you comply with the law, please be sure to carefully review the attached letter from the Chief of Police with regard to the Borough's sign ordinance which explains the requirements for posting Garage Sale signs.
- 5) Be sure to have your Garage Sale Permit on the premises at which the sale will take place.

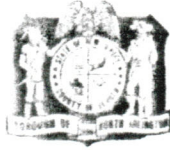

Dear Resident,

Borough Ordinance **185** prohibits sign posting on telephone poles and on public property. The Ordinance includes posting of signs for yard sales, garage sales, and similar events.

**185-7 [Amended 8-9-2004 by Ord. No. 1922]**

Temporary signs are permitted only on the days of the sale, and only on the premises on which the sale is to take place. No temporary signs are permitted on public property or within any public right-of-way or sidewalk. This requirement extends to trees, telephone poles and street or traffic signs. All temporary signs are to be removed simultaneously with the ending of the sale. No more than two signs advertising the garage sale shall be permitted on the premises, and no sign shall be more than four square feet in size.

**185-9 [Amended 8-9-2004 by Ord. No. 1922]**

This chapter may be enforced by any officer of the Borough of North Arlington, including the Police Department and the Construction Department. It shall be the duty of such officer to investigate any reported violation. Any such official shall be required to act in any manner necessary in order to assist in the enforcement and provisions of this chapter.

Please follow the above to ensure your sale is in compliance of law
